What You Will Do/Need (Job Summary)

RAHAB's Meal Makers are dedicated to providing a warm, homemade meal to the youth who come to the Mentoring Center. The goal is to make the youth feel comfortable and open to engagement while their physical needs are being met. Meals are prayed over and intentionally made to bring spiritual and physical healing and nutrition to the youth.

Responsibilities (Essential Duties and Responsibilities)

Administrative:

- Plan and prepare nutritious meal (must feed 8-10 people)
- You can sign up on our Sign-up genius as often as you would like
- Willing to donate time and gas to drive to drop off location (Mentoring Center)
- Willing to make meals for youth as a donation (non-reimbursable)
- Generously gifting a meal to our mentoring center (non-reimbursable)
- Allergies (No onions, mushrooms, olives, peanuts/tree nuts, or any additional allergies specified by MMP staff)
- Best way to stay connected: Facebook or sign-up genius link

Coordination:

- Must be able to drive to our Mentoring Center to drop off meal
- Drop off hours
 - School year: 3pm-4:30pm
 - Summer: 2-3:30pm
 - *Talk with Volunteer coordinator for Drop Off instructions*
